## Overview



Updated 2/25/2021

CMS continues to offer flexibilities to provide relief to clinicians responding to the 2019 Coronavirus (COVID-19) pandemic.

We are applying the MIPS automatic extreme and uncontrollable circumstances (EUC) policy to all MIPS eligible clinicians for the 2020 performance period.

We are also **reopening** the MIPS EUC application for individual MIPS eligible clinicians, groups, virtual groups, and Alternative Payment Model (APM) Entities through March 31, 2021.

**Please note that applications received between now and March 31, 2021 at 8 p.m. ET won't override previously submitted data for individuals, groups and virtual groups.**

## General Information

We are extending the application deadline to [submit a COVID-19 related extreme and uncontrollable circumstances application](#) to March 31, 2021.

- A [HARP account](#) is required to submit an application.
- Third-party intermediaries can also submit an application on your behalf with your permission.

**Note:** Extreme and uncontrollable circumstances applications not related to COVID-19 must be submitted before December 31, 2020 to be considered for approval.

## Individuals, Groups, and Virtual Groups: General

### **Applications can be submitted for one or more performance categories.**

- Any performance category that isn't included in the application is eligible for scoring, even if no data are submitted, unless the clinician or group qualifies for reweighting under another policy.

### **Any data you submit, or someone submits on your behalf, will override reweighting for that performance category and the category will be scored.**

- If the cost performance category is included in the application, cost measures won't be scored even if data is submitted for other performance categories.
- **IMPORTANT:** Even though we are extending the deadline for COVID-19 related extreme and uncontrollable circumstances applications into the PY 2020 submission period, individuals, groups and virtual groups can't submit an application to override PY 2020 data that has been submitted. **Any data submitted for an individual, group, or virtual group before or after an application has been approved will be scored.**

### **You must be scored on at least 2 performance categories to earn a MIPS Final Score other than the performance threshold.**

- When fewer than 2 performance categories can be scored (meaning 1 performance category is weighted at 100% of your final score, and the other performance categories are weighted at 0%), the final score for the 2020 MIPS performance period would be equal to the performance threshold and you would receive a neutral payment adjustment in 2022.



## Individuals, Groups, and Virtual Groups

### Individual Participation

- Individual clinicians don't need to submit an exception application because we are applying our automatic extreme and uncontrollable policy to all MIPS eligible clinicians.
- If you haven't submitted data, or have submitted data for a single performance category (such as Medicare Part B Claims quality measures reported throughout the performance period), you will receive a neutral payment adjustment unless you have a higher score from group participation.
- If you've submitted data in 2 or 3 performance categories, you will receive a MIPS final score and MIPS payment adjustment for the 2022 MIPS payment year based on the data you've submitted.
- You will only be scored in the performance categories for which data are submitted.

### Group Participation

- Groups that haven't submitted any data don't need to submit an exception application if you're not able to submit data for the 2020 performance period. Group participation is optional, and your individually MIPS eligible clinicians qualify for the automatic extreme and uncontrollable circumstances policy.
- Groups that have submitted data for a single performance category and are unable to submit data for other performance categories can submit an EUC application to reweight all 4 performance categories; if your application is approved, your MIPS eligible clinicians will receive a neutral payment adjustment for the 2022 MIPS payment year unless they have a higher final score from individual participation.
  - If you don't submit an application, your group will be scored in all 4 performance categories unless the group qualifies for reweighting in one or more performance categories.
- Groups that have submitted data for 2 or 3 performance categories can submit an application for any remaining performance category or categories; if your application is approved, your MIPS eligible clinicians will receive a final score based on the data submitted unless they have a higher final score from individual participation.
  - If you don't submit an application, your group will be scored in all 4 performance categories unless the group qualifies for reweighting in one or more performance categories.

## Individuals, Groups, and Virtual Groups

### Virtual Group Participation

- Virtual groups that haven't submitted any data or have submitted data for single performance category and are unable to submit data for other performance categories can submit an EUC application to reweight all 4 performance categories: if your application is approved, your MIPS eligible clinicians will receive a neutral payment adjustment for the 2022 MIPS payment year.
  - If you don't submit an application, your virtual group will be scored in all 4 performance categories unless the virtual group qualifies for reweighting in one or more performance categories.
- Virtual groups that have submitted data for 2 or 3 performance categories can submit an application for any remaining performance category or categories; if your application is approved, your MIPS eligible clinicians will receive a final score based on the data submitted.
  - If you don't submit an application, your virtual group will be scored in all 4 performance categories unless the virtual group qualifies for reweighting in one or more performance categories.

## Individuals, Groups, and Virtual Groups *(continued)*

### Example

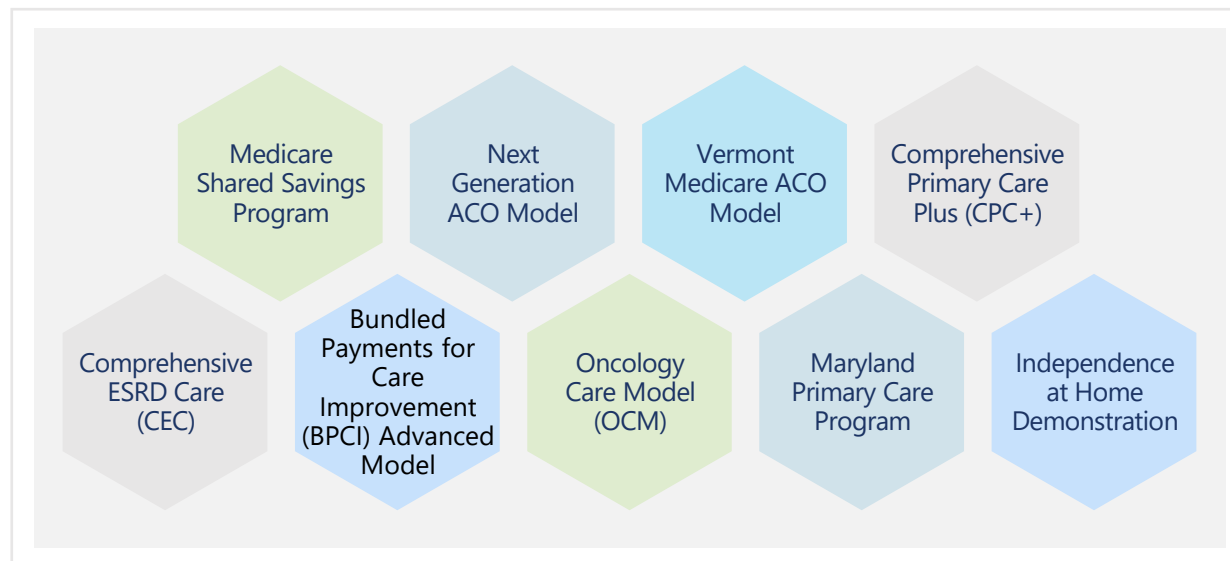
Your group application to have all 4 performance categories reweighted was approved, but you later determine you're able to submit data for the improvement activities and Promoting Interoperability performance categories:

- You will receive a MIPS Final Score based on the data submitted.
- The improvement activities performance category will be weighted to 15%.
- The Promoting Interoperability performance category will be weighted to 85% of your final score.
- The quality performance category will retain a 0% weight because you didn't submit quality data.
- The cost performance category will retain a 0% weight because there are no data submission requirements associated with the cost performance category (reweighting can't be voided).

## APM Entities

We have finalized a policy to allow MIPS APM Entities to submit a PY 2020 Extreme and Uncontrollable Circumstances Exception Application for all MIPS performance categories.

- This policy was finalized in the CY 2021 PFS Final Rule and applies to the following models:



## APM Entities *(continued)*

### **APM Entity applications must be submitted for all performance categories.**

- You can't submit an application for an APM Entity to request reweighting in 1 or 2 performance categories.
- This is different from our policy for individual, group, and virtual group applications.

### **If your APM Entity's application is approved, the APM Entity will receive a final score equal to the performance threshold and the MIPS eligible clinicians in the APM Entity group would receive a neutral payment adjustment even if data are submitted for the APM Entity.**

- Data submitted for an APM Entity will not override performance category reweighting from an approved application.
- This is different from our policy for individual, group, and virtual group applications.

### **An approved application won't affect your model-specific reporting requirements.**

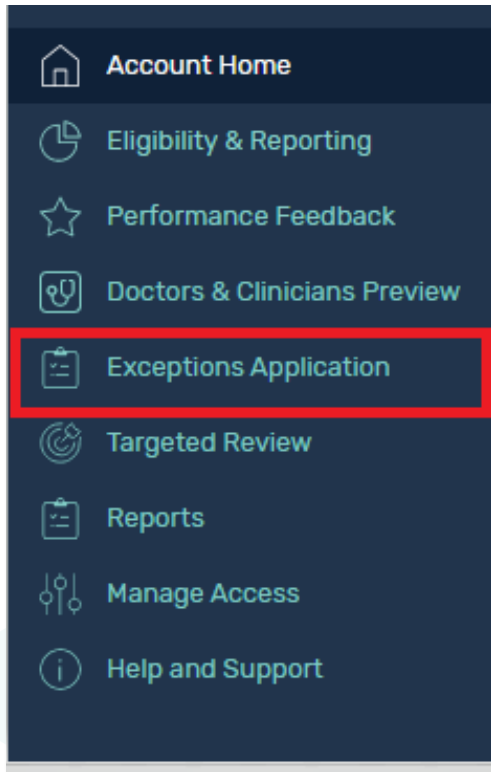
- For example, Shared Savings Program ACOs must still report their quality measures through the CMS Web Interface to meet their requirements under the Shared Savings Program, unless otherwise excepted under that APM.



## Application Steps



## Steps 1-4




1. [Register for a HARP account](#) if you don't have one.
2. [Sign in to qpp.cms.gov](#) with a HARP account to submit an application.
3. Click **Exceptions Application** on the left-hand navigation.
4. Click **Add New QPP Exception**.




## Step 5

5. Choose the Extreme & Uncontrollable Circumstances Exception option.

MIPS eligible clinicians, groups, and virtual groups may submit a Promoting Interoperability Hardship Exception Application citing one of the following specified reasons:

- You're a small practice
- You have decertified EHR technology
- You have insufficient Internet connectivity
- You face extreme and uncontrollable circumstances such as disaster, practice closure, severe financial distress or vendor issues
- You lack control over the availability of CEHRT

☒ Extreme and Uncontrollable Circumstances Exception

The Extreme and Uncontrollable Circumstances application is reserved for instances where there is indeed an Extreme and Uncontrollable Circumstance, such as a **natural disaster, public health emergency or other significant event**, that prevents collecting data for an extended period of time, or that could impact performance on cost measures.

## Step 6

6. Select the application type based on the level at which you intend (or intended) to participate in MIPS:
  - **Individual**
    - National Provider Identifier (NPI) and practice affiliation required
  - **Group**
    - Taxpayer Identification Number (TIN) required
  - **Virtual Group**
    - Virtual Group identifier required
  - **APM Entity**
    - APM Entity ID required

**Note:** If you're only requesting reweighting of 1 or 2 performance categories and intend to submit data for others, it's critical that you select the application type that aligns with the level at which you intend to submit data to MIPS (at the individual or group level.)

9. Cite **COVID-19** as the event and indicate the date range (March 2020 – present). Only applications related to COVID-19 will be considered for approval after December 31, 2020.

## Step 10

10. Write a brief description about the data collection challenges the clinician or group is facing as a result of the COVID-19 pandemic or include concerns about the effect that the COVID-19 pandemic will have on PY 2020 performance data, including cost measures.

**No supporting documentation is required to submit an application.**

### **Example** (brief description/concerns)

Due to the COVID-19 pandemic, many of our processes, workflows, and resources have shifted to care for patients at high risk with urgent and severe medical conditions. This shift has adversely affected our ability to collect 2020 performance data, changed our patient population and the validity of measure data we could collect, and has affected the cost of care we're providing.

## Steps 11 & 12

11. Check the box next to each performance category for which you are requesting reweighting.

Note that all performance categories will be automatically selected for APM Entity applications.

12. Click Submit for Review.

### Performance Categories Affected \* ?



#### Quality

This category covers the quality of the care you delivered, based on performance measures created by CMS, as well as medical professional and stakeholder groups. **Do not select this category if you were able to report data for at least one year.**



#### Promoting Interoperability

This category focuses on patient engagement and the electronic exchange of health information by proactively sharing information with other clinicians or the patient in a comprehensive manner. **Do not select this category if you were able to report data for at least 90 days.**



#### Improvement Activities

This category includes an inventory of activities that assess how you improved your care processes, enhanced patient engagement in care, and increased access to care. **Do not select this category if you were able to report data for at least 90 days.**



#### Cost

The cost of the care you provide is calculated by CMS based on your Medicare claims. MIPS uses cost measures to gauge the total cost of care during the year or during a hospital stay. **Selecting this category will have no effect on your exception outcome.**
