Accessing the CMS Web Interface Support Calls

The Centers for Medicare & Medicaid Services (CMS) is hosting a series of support calls for Medicare Shared Savings Program Accountable Care Organizations (Shared Savings Program ACOs) that are reporting quality data through the CMS Web Interface for the 2023 performance period. The support calls will highlight important information and updates regarding the reporting of quality data via the CMS Web Interface. Shared Savings Program ACOs have an opportunity to engage in Q&A sessions with CMS subject matter experts during the support calls.

The CMS Web Interface is a secure, internet-based data submission mechanism. The CMS Web Interface continues to be an option for Shared Savings Program ACOs meeting reporting requirements under the APM Performance Pathway (APP) through the 2024 performance period.

The submission period opens on January 2, 2024, and closes on March 31, 2024, at 8 p.m. ET.
